



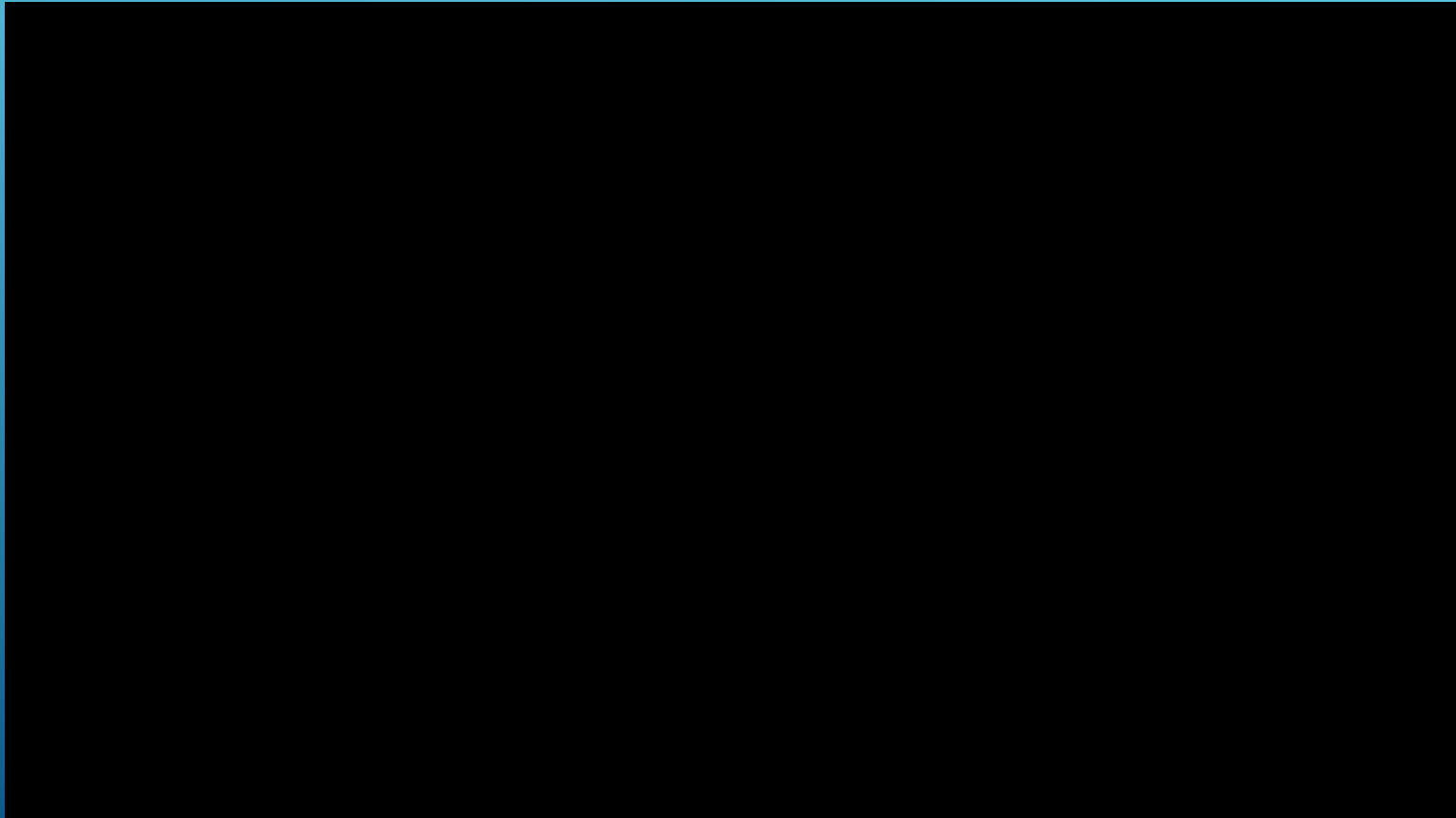

Classroom safety while distance Learning:

- Continue to engage, equip, and empower youth and community members to be part the learning process.
- Create safer schools and communities through prevention and early intervention with online safety protocols known.
- Enhance efforts to assist with cultivating positive cultures and climate.

STOP GRANT:

Goals for the grant include the following:

- ▶ Supports for k-12 and Higher Ed. on being proactive before school violence or attacks on school grounds occur.
- ▶ Training for Administration, staff and school personnel and when and how to report incidents effecting the school environment.
- ▶ Communication/collaboration with local agencies and law enforcement to create this positive partnership on being more proactive on stopping school violence.

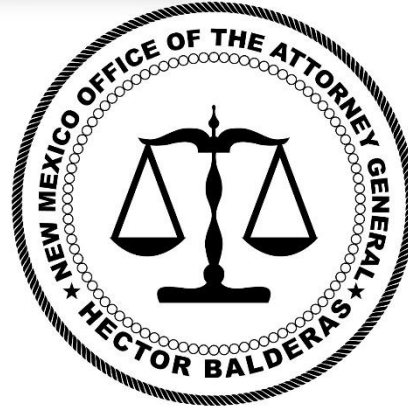
