### Introduction

### 22-29-2. Purpose of act.

The purpose of the Public School Insurance Authority Act is to provide comprehensive core insurance programs, including reimbursement coverage for the costs of providing due process to students with disabilities, for all participating public schools, school board members, school board retirees and public school employees and retirees by expanding the pool of subscribers to maximize cost containment opportunities for required insurance coverage.

- Development of both Functional Behavioral Analysis (FBA) and behavioral intervention plan

- Trouble shooting potential issues:
- Review IEP for Individualizations
- Provide Recommendations in Engaging both Parent and Advocate at IEP Meetings
- Writing appropriate attainable goals that address current and future performance
- Ensuring timelines regarding annual IEP's and re-evaluations are up to date
- Training individuals on looking up legal/compliance information on their own
- Ensuring that students with significant health and or mental health needs are provided with appropriate educational services without disruption (on school campus or at home)

# **Ergonomics and Job Hazard Analysis**

- Almost 20% of worker's comp reports are listed with No Obvious Cause
- Number one cause for injury –Slips, Trips and Falls
- Teachers, EA's, Administrators, and Clerical Employees account for over 44 million of the incurred losses
- Custodian, maintenance and cafeteria almost 34 million
  - Risk Management Recommendation
  - Site Audit






# **Property**

- NATURAL CATASTROPHES in the US
  - 170 billion in 2021
  - Civil Disorders 2020 were estimated between 500 million
    - 900 million they came in well over 2 billion
  - Hurricanes and wildfires were by far the most expensive In fact, these storms alone comprised 81.2% of costs
    - Estimates for 2021 112 + billion (does not include the tornadoes and wildfires in December
    - Colorado wildfire insured losses pegged at about \$1 billion
    - The fourth highest on record
      - Hurricane Katrina in 2005 approx. 150 billion,
      - 3 Hurricanes in 2017 approx. 161 billion


- Act of God \$50,000,000







# Removal of Qualified Immunity

- Oxford High school shooting –Oxford township, Michigan November 30
  - Four students were killed and seven people were injured, including a teacher
  - Arrested and charged 15-year-old <u>sophomore</u> Ethan Crumbley <u>as an</u> <u>adult</u> for 24 crimes, including murder and terrorism
- Now the interesting part
  - New filing by survivors of shooting for \$100 million
  - Superintendent, Principal and others accused of gross negligence, intentional infliction of emotional distress and failing to prevent the massacre
  - Accuses the defendants of making students less safe through their actions
    - Causing students to be in direct harm and acting in a manner that was so reckless as to demonstrate a substantial lack of concern
- Will claim qualified immunity No longer available in NM
  - must show that a public official violated "clearly established law"
